Eligibility Requirements for Foreign Nationals

Eligible Recipients

Foreign nationals may be included as eligible recipients if they meet certain requirements

(Additional subsidy is also provided if classified as a vulnerable group) * based on resident status as of June 18, 2025

- O For general foreign nationals
 - ① Must be listed in the resident registration with at least one Korean national included, and
 - ② Must be enrolled in the National Health Insurance (including deferred payment), be a dependent, or a recipient of Medical Aid
- For permanent residents (F-5), marriage immigrants (F-6), or recognized refugees (F-2-4)
 - ① Must be enrolled in the National Health Insurance, be a dependent, or a recipient of Medical Benefits

Substantial and focused support for lower-income & single-parent families, and basic livelihood support recipients

- Eligibility, amount, and other details will be individually notified through the "People's Livelihood Recovery Consumption Coupon Notification Service*."
- * Apply via the Virtual Assistant Service for the Public website (http://ips.go.kr), Naver App (e-document service), KakaoTalk (Goodpy channel), or Toss (My Document).









Preventing Smishing Scams and Public Guidance

Be aware of smishing or spam texts impersonating People's Livelihood Recovery **Consumption Coupon notifications!**



Never click on any URL links

The government and credit card companies do not include any URLs or links in text messages related to the online application for the Livelihood Recovery Consumption Coupon, in order to prevent fraud or scams. **If a text message** regarding the People's Livelihood Recovery Consumption Coupon contains a URL or link, it is 100% a scam.



What is Smishing? Smishing is a type of scam in which malicious app links are sent via text message, deceiving you into installing the apps or making phone calls. This allows attackers to steal your financial and personal information.
